

#### **Transition update**

As we approach transition to Identitywa Disability Services Limited on 31 August 2025, we thank all our participants and families for being so responsive and working with our teams to enable a smooth transition.

#### A new era of living – what's on the horizon!

Our forward-thinking housing strategy has to date resulted in more than 35 participants thriving in 13 new houses designed with comfort, safety and independence in mind. And we're just getting started. With 17 more homes on track for completion over the next 12 months, over 90 people will be living in modern homes that are less than five years old, by mid-2026.

### New homes, new beginnings

In June, five people supported by Identitywa, each with Specialist Disability Accommodation funding in their NDIS plans, moved into two new purpose-built homes in Balcatta. These vibrant, modern spaces provide greater independence, community connection and a place to truly call home.

TV Property Group constructed these homes to meet the Specialist Disability Accommodation (SDA) design standard of Improved Liveability. This company is comprised of family members of a participant supported by Identitywa who now lives in one of these newly built these homes.

The homes incorporate all the features included in Identitywa's new homes along with several passive solar features.

Elevated windows allow natural airflow and cooling. The inclusion of eaves in addition to window placement and orientation permit warmth from the sun in winter and block the sun and heat in summer.

The energy-efficient design features include a concrete floor which acts as a thermal mass, absorbing and releasing heat to maintain consistent indoor temperatures year-round, greatly reducing reliance on artificial heating and cooling.

Eligible participants who have been with Identitywa for 12 months or more can apply for funding to support a range of activities, including:

# SCHOLARSHIPS AVAILABLE - APPLY BY 31 AUGUST 2025

We are looking forward to Pope Leo XIV's spiritual leadership marked by peace, unity, and a deepening of the Gospel message.



### **Introducing Clinical Governance Lead Tracy**

Tracy Foulds joined Identitywa as the Clinical Governance Lead in January this year. Her main role being the review of practices, to identify trends and develop strategies which improve the quality of services for participants, with a focus on the human rights of people with disability. Tracy has enjoyed getting to know workers and participants at the houses and is keen to keep doing so in the future.

Tracy first started working in the disability sector more than 25 years ago as a support worker for children with disability and as a rostering officer and coordinator of children's respite. While working at the Disability Services Commission, now the Department of Communities, Tracy held a number of roles, including responsibility for the development and management of the People at Risk Team, ensuring the Commission identified participants who were at risk of harm and establishing appropriate strategies to minimise the risks.

Tracy was CEO of Headwest, an advocacy service for people with brain injuries and due to changes in funding, established Explorability to create a person-centred advocacy service for people with all disabilities. Tracy led Explorability for more than five years before joining NDS WA to support disability organisations to transition to the NDIS Quality and Safeguards Commission. Before joining Identitywa, Tracy held the position of Quality and Safeguarding General Manager for a small provider of supported independent living and community participation. Welcome to the team Tracy.

# Conflicts of Interest in Service Delivery

#### What is a conflict of interest?

A conflict of interest is where an organisation or person has an opportunity to put what benefits them (their own interests) ahead of the participant's interest. It could be about money or business, people (workers or other people who support a participant), cultural or religious beliefs, and personal or social relationships.

#### Conflict of interest in service delivery

As a provider of multiple NDIS services, Identitywa recognises that conflicts of interest may arise during service delivery. Identitywa assures that conflicts of interest will be identified, reported, managed, and documented as they arise, ensuring the continuous delivery of quality and safe supports to participants.

## What if you would like Identitywa to provide more than one service?

If you are interested in having Identitywa provide more than one support (e.g., SIL and Community, SIL and SDA, etc.) we will declare our potential conflict of interest to you and your representative. We will talk to you about what it means and how we will manage and monitor any conflict of interest.

We will ensure you understand the risks and that you agree with the plan on how to manage it. These will all be recorded using the new Conflict of Interest in Service Delivery Guidance form.



## What if I choose another Provider instead?

You are always free to choose your preferred provider. Identitywa will not influence you to choose Identitywa and any decisions you make about your providers or supports will not impact the current support/s we provide you. We will always respect and support your decision. If you choose or are referred to another provider, we will assist you with your transition from our service.

#### Practice to Celebrate!

In 2017 Identitywa entered a partnership with La Trobe University with the goal of focusing our attention on participant quality of life through fantastic active support. As part of the partnership, La Trobe researchers visited some of our shared living services to observe and interview staff on our active support and practice leadership.

We recently received our results from July 2024 to January 2025 and we have reason to celebrate! Thanks to the investment from our wonderful support workers, practice leaders and all involved from Identitywa, we have met some incredible practice milestones and want to share some of our achievements and future areas of focus.

#### Where we excelled

- We had a measurable improvement across almost every domain. This tells us we're getting it right and making a real difference for the participants we support.
- We meaningfully engaged participants
   71% of the time meaning we engage
   Participants on average for 43 minutes of every hour. This is a 9% increase from the previous year and is 16% higher than the national average!

- We had a significant improvement in our practice leadership. We had an increase of 12.5% - 37.5% across all of the five tasks of practice leadership and scored above the national average for every single task.
- Our staff satisfaction was 79% we're proud to have a workforce passionate about providing excellent active support.

## The set of 5 tasks that are critical to ensuring good quality support for Participants



### Future areas of focus

- The quality of our good active support has gone up 1% which is fantastic however, we want to explore how we can strengthen that continuous improvement.
- Our social activity went down this year and we're keen to focus on supporting positive social interactions for people in their home and community.
- We're sustaining how we support people with cooking activities and in the garden and we want to increase opportunities for people to engage in their household tasks.
- La Trobe has given us direct insights on where we need to focus our attention.
   Our priorities will be on great supervision, shift planning, observation and coaching and supporting people well with higher support needs.
